### Parking

Long and short term parking is available next to the terminal building. Payment for your car parking can be made at the pay stations by credit card.

### **Short Term Car Parking Tariff**

First 30 minutes FREE  
30 mins – 1 hour €1.00  
Maximum rate for 24 hours €15.00

### **Long Term Car Parking Tariff**

1 Day €7.50  
2 Days €15.00  
Then €5 per day

### Train

The train station is called Hoek Van Holland Haven and is situated next to the ferry terminal.

### Check-In Times

#### **Accompanied:**

45 minutes prior to scheduled departure time (WB 14.30 sailing only 30 minutes before scheduled departure time)


#### **Unaccompanied:**

90 minutes prior to scheduled departure time (WB 14.30 sailing only 60 minutes before scheduled departure time)

#### **Hazardous:**

180 minutes prior to scheduled departure time

An advance booking will be necessary before entering the port and recommended to secure space for a sailing.

Environmental license restriction in the Hoek van Holland limits certain type of hazardous goods on the quay side. For information one can contact the local Reservations in Hoek van Holland.

The transport of live animals is always subject to weather conditions and the acceptance of this cargo is for own responsibility.

Entrance to the port of Hoek van Holland is limited due to the fact that all vehicles have to cross the railway line with overhead power cable with a maximum height is 4.3m.

### **Delivery of freight units:**

The delivery of any type of freight unit (both accompanied and unaccompanied) to the port of departure can only been done when a prior booking for a specific sailing has been confirmed. The freight unit will NOT be allowed entrance to the terminal without a confirmed booking.

### **Parking**

After shipment and arrival in Hoek van Holland any unaccompanied unit will be parked for a maximum of 3 days free of charge.

The first 3 days (excluding the day of arrival) are included in the price, after which the following charges will apply:

<b>4 - 15 days</b>	€ 11,50	£ 10 per day
<b>16 - 20 days</b>	€ 16,50	£ 14.35 per day
<b>21 - 25 days</b>	€ 21,50	£ 18.75 per day
<b>+ 25 days</b>	€ 26,50	£ 23 per day

Delivery of unaccompanied vehicles is permitted up to 24 hours prior to the booked departure. Temporary parking at check-in is only allowed to maximum of 15 minutes. All vehicles will be directed to the designated waiting area or to the vessel. All drivers must wear a high visibility vest when driving on the terminal.

Unaccompanied units with dangerous substances must be collected within 12 hours after discharge. Storage of unaccompanied or self drive units is not possible in Hoek van Holland.
